SUBJECT: CREATION OF SPECIAL TASK FORCE TO MONITOR AND ENFORCE COMPLIANCE OF BUSINESS ESTABLISHMENTS IN THE MUNICIPALITY OF ITOGON WITH MUNICIPAL ORDINANCES, RULES AND REGULATIONS.

WHEREAS, the reports from the Philippine National Police (PNP) personnel and Barangay Authorities on violations of Municipal Ordinance No. 02, s. 1992 and infractions of Municipal Ordinance No. 22, s. 2003, respectively, have surged in this Municipality;

WHEREAS, Municipal Ordinance No. 02, s. 1992 provides for the law on dispensation or sale of liquor and other intoxicating beverages within the Municipality while Municipal Ordinance No. 22, s. 2003 established a curfew on all minors in the locality;

WHEREAS, numerous issues and concerns inimical to public interest and welfare have likewise risen in an alarming rate as a direct result of the aforesaid violations or infractions of the afore-described Municipal Ordinances;

WHEREAS, it now becomes imperative for the Officialdom of Itogon Municipality to adopt responsive and stringent measures to ensure that these two (2) very significant Municipal Ordinances be strictly enforced or implemented and complied with within the Municipality;

WHEREAS, this endeavor, to be successful, needs the participation of every concerned and responsible stakeholder such as the Office of the Local Chief Executive, Office of the Sangguniang Bayan, Barangay Officials, and the constituency at large;

NOW, THEREFORE I, OSCAR MAINGPES CAMANTILES, Municipal Mayor of Itogon, by virtue of the powers and authority vested in me by law, hereby direct and order the creation of a Special Task Force to Monitor and Enforce Compliance of business establishments in the Municipality of Itogon with Municipal Ordinances, Rules and Regulations.

Section 02. Duties and Functions

1. Conduct constant monitoring and surveillance operations on establishments and areas where reports of rampant violations of Municipal Ordinances are prevalent to firmly enforce the pertinent ordinances;
2. Formulate a strategic plan and a standard operating procedure to be adopted in its operations;
3. Make detailed reports of such monitoring and surveillance operations to support the possible actions that may be deemed appropriate as the circumstances may warrant against the erring establishments or operators;
4. Encourage the constituency to fully cooperate and participate in this critical venture to promote a peaceful and orderly society;
5. Coordinate with the respective Barangay Officials when deemed necessary to effect a more efficient and successful conduct of operations;
6. In extreme cases, to recommend or file for legal remedies as a last resort to the proper authorities;
7. Perform such other functions necessarily related or material in the realization of the Special Task Force's duties and functions.

Section 03. Effectivity – This Order shall take effect immediately
