ADMINISTRATIVE ORDER NO. 025-2011 Series of 2011

CREATING A SPECIAL FACT FINDING TEAM TO DETERMINE THE STATUS OF THE VARIOUS STRUCTURES AND ESTABLISHMENTS ERECTED IN AREAS ADJACENT TO THE MUNICIPALITY'S MRF FACILITY AND BENGUET CORPORATION'S PHASE 1 & 3 TAILINGS POND

WHEREAS, it is a glaring observation that numerous structures have sprung up like mushrooms in the adjacent areas of the Municipality's Material Recovery Facility as well as Benguet Corporation's Phase 1 and 3 Tailings Pond;

WHEREAS, these structures allegedly include shacks and ballmills or leaching plants which have not secured any clearances or permits from the concerned municipal authorities as per verifications;

WHEREAS, Benguet Corporation informed the Municipality that it has not issued any consent on the use of the area to the owners of the structures or operators of the ventures thereon:

WHEREAS, the Environmental Management Bureau and the Mines and Geosciences Bureau of the Department of Environment and Natural Resources have allegedly conducted inspections and reports requiring the filing of the appropriate documents and Environmental Compliance Certificate by the ballmills and leaching plants operators;

WHEREAS, it becomes undeniable that the Municipality has to be involved in the matter at issue to set things in their proper order and to enforce its ordinances, rules and regulations on environment protection and preservation, building permits, and on businesses or ventures;

NOW THEREFORE, I, OSCAR MAINGPES CAMANTILES, Municipal Mayor of Itogon, by virtue of the powers and authority vested in me by law, hereby direct and order the creation of a Special Fact Finding Team to be composed of the following:

- 2. Type of structure or venture introduced;
- Status and compliance of the structure/venture introduced as regards permits, clearances or documents legally required for the subject improvement/operation;
- 4. Status of the structure/venture in connection to the lot over which it is presently erected/situated;
- 5. Recommendation of appropriate action(s) as may be warranted by the facts gathered.

This Administrative Order shall take effect immediately.
