[Signature] **CREATING TASKFORCE LABILAB**

WHEREAS, the Department of Agrarian Reform (DAR) through the Municipal Agrarian Reform Office (MARO) is currently implementing an agrarian reform project at sitio Labilab, Barangay Loacan particularly concerning that certain parcel of lot covered and embraced by Original Certificate of Title (OCT) No. CLOA-6305 under the name of FEVA D. TABDI, ET AL consisting of an area of Four Hundred Ninety-Seven Thousand Seven Hundred Forty Square Meters (497,740 sq.ms.);

WHEREAS, conflicts and disputes have sprouted from several contesting factions and personalities in the planned subdivision and award of the afore-described parcel of lot to the identified beneficiaries as a result of allegedly questionable survey plans, inclusion of strangers in the beneficiaries' list, non-inclusion of rightful claimants in the beneficiaries' list, and unwarranted repetitions of claimants' names in several of the subdivision lots;

WHEREAS, these issues, if they remained unsatisfactorily resolved shall hamper the attainment of the goals and objectives of agrarian reform in said locality;

WHEREAS, in line with its social development program on land tenure, it is deemed necessary for the Municipal Government of Itogon to assist the concerned parties and the DAR through the creation of a Task Force to facilitate the bringing about of prompt resolution of the issues that are amiable to all concerned parties but not to supersede the DAR in the performance of its primary functions;

NOW THEREFORE, I, OSCAR MAINGPES CAMANTILES, Municipal Mayor of Itogon, by virtue of the powers and authority vested in me by law, hereby direct and order the creation of a Task Force with the primary function and objective of resolving the issues presently hounding the implementation of the DAR's agrarian reform program on that certain parcel of lot covered by OCT No. CLOA-6305 situated at Barangay Loacan, Itogon, Benguet; to wit:

Section 1. The Task Force shall be known as TASKFORCE LABILAB and shall be composed of the following:

Section 2. The Task Force shall have a support technical team to be composed of the following:

Team Leader : MR. AVELINO S. MEDINA, JR. 7/20/11
Members : MS. LUCIA A. COMISING 7/20/11

Section 3. The Task Force shall have the following duties and functions:

- a) To formulate and adopt appropriate measures or strategies to facilitate the speedy resolution of the issues between and among the conflicting parties;
- b) To mediate or conciliate between the contesting parties and recommend alternative-solutions agreeable to the parties involved;
- c) To perform such other functions in accordance with the MARO's action plan in bringing to fruition the DAR's agrarian reform program particularly with that lot covered and embraced by OCT No. CLOA-6305.

Section 4. The Municipal Government of Itogon shall endeavor to provide for the necessary and sufficient funds for the realization of the Task Force's objectives chargeable against its 2011 FY allocation for land tenure development program, subject to accounting rules and regulations.

This **Order** shall take effect immediately.
