SUBJECT: CREATION OF AN ADHOC COMMITTEE FOR THE CONDUCT OF ACTIVITIES UNDER THE BANTAY BATA 163 AND FOR THE ACHIEVEMENT OF THE OBJECTIVES THEREOF
