AN ADMINISTRATIVE ORDER CREATING THE MUNICIPAL RECOGNITION COMMITTEE FOR OUTSTANDING BARANGAY PEACE AND ORDER COMMITTEE (BPOC) ON CRIME PREVENTION


WHEREAS, DILG Memorandum Circular No. 2005-84 dated 23 August 2005 calls for the creation of a Municipal Recognition Committee to recognize outstanding Barangay Peace and Order Committees;

WHEREAS, the objective of the awards is to strengthen the POCs at various levels and ensure a more enhanced involvement, mutual assistance and coordination among all sectors of the community in the attainment of peace, law and order, public safety and security in the country;

WHEREAS, the POC award shall be conferred upon by the committee which has demonstrated exemplary performance in coordinating the accomplishment of programs and projects on peace, law and order, public safety and security;

NOW THEREFORE, by virtue of the powers vested in me as Municipal Mayor of Itogon, Benguet, do hereby create the Municipal Recognition Committee for Outstanding Barangay Peace and Order Committee (BPOC) whose composition and functions shall be as follows:

Section 2. Functions. The Committee shall perform the following functions:

1. Take the lead in the selection of the outstanding Barangay Peace and Order Committees (BPOC) in the municipality;
2. To institutionalize a system of providing incentives and rewards to outstanding BPOCs; and
3. Submit the name/s of BPOCs that will be awarded by the municipality to the Regional Level POC.

Section 3. Secretariat. The DILG Municipal Field Office shall be designated as the secretariat to assist the committee in the documentation of proceedings of meetings and others as may be requested.

Section 4. Effectivity. This Administrative Order takes effect immediately and amends previous issuances.
