AMENDING ADMINISTRATIVE ORDER NO. 02-13-N

WHEREAS, Administrative Order No. 02-13-N was promulgated designating Ms. Laurie F. Pangda as the Municipal Tourism Action Officer who shall be the front liner in the implementation of tourism-related projects, programs and activities of the municipal government;

WHEREAS, considering the workload of Ms. Laurie F. Pangda as a social welfare service provider under the Municipal Social Welfare and Development Office, as well as the clientele assigned to her, the undersigned deems it but appropriate to relieve her of other additional functions so that she could focus more on attending to the needs of our elderly and such other clients of the MSWDO with the end view of providing efficient and adequate social welfare services to our constituents;

NOW THEREFORE, by virtue of the powers vested in me by law, I, **ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby amend Administrative Order No. 2-13-N as follows:

Section 1. Mr. Nestor Camado Jr. is hereby designated as the Municipal Tourism Action Officer in lieu of Ms. Laurie F. Pangda.

Section 2. The MTAO-Designate by virtue hereof shall continue to perform the duties and functions of such office as provided by law and other rules and regulations without disregard to the rendering of assistance on tourism matters by Ms. Laurie F. Pangda until such time that the MTAO-designate gets fully acquainted of such duties and functions.

Section 3. All Administrative Orders and Issuances inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

Section 4. This Administrative Order shall take effect on June 2nd, 2014.
