REORGANIZING THE MUNICIPAL GOVERNANCE PERFORMANCE MANAGEMENT SYSTEM (LGPMS) TEAM

WHEREAS, the Local Governance and Performance Management System (LGPMS) is a web-based national information system for and about LGUs that stakeholders can access via internet;

WHEREAS, the development of the LGPMS is motivated by the desire of the DILG to see that LGU performance measurement is being used effectively in LGU management, service delivery and development planning processes;

WHEREAS, the LGPMS provides LGUs a way to measure and assess their capacity and performance and identify their weaknesses and strengths in an objective manner to allow to develop appropriate strategies and actions towards building up capacity and improving performance in the delivery of services to the constituents;

WHEREAS, the need for such management tool is made more urgent and relevant given the challenges of local administration and development;

WHEREAS, LGPMS is being implemented every year;

NOW THEREFORE, by virtue of the powers vested in me as Municipal Mayor of Itogon, Benguet, do hereby reorganize the Local Governance Management System (LGPMS) Team whose composition and functions shall be as follows:

- Plan, oversee, coordinate, monitor and evaluate the implementation of the LGPMS;
- 3. Prepare the State of the Local Governance Report (SLGR) of the Municipality;
- 4. Provide the next higher level with its State of Local Governance Report;
- 5. Establish and maintain a municipal computer-based LGPMS databank;
- Hold exit conferences to brief local elective officials and functionaries on LGPMS findings and recommendations; and
- 7. Attend to their similar tasks and responsibilities as may be necessary and appropriate.

SECTION 3. SECRETARIAT. A secretariat shall be designated to assist the team in gathering and consolidating the data as well as in data entry, to wit:


