**ADMINISTRATIVE ORDER NO. 12**

**REORGANIZING THE MUNICIPAL TECHNICAL COMMITTEE ON ORGANIC AGRICULTURE.**

**WHEREAS**, among the priority programs of this administration is focused on the promotion and development of organic agriculture in the municipality which aims to ensure food security, address concerns on health and wellness, provide livelihood and employment and alleviate poverty while protecting the environment and contributing to international efforts to address issues and concerns on environmental protection, global warming and climate change adaptation;
