**ADMINISTRATIVE ORDER No. 14-13**

**REORGANIZING THE MUNICIPAL ECOLOGICAL SOLID WASTE MANAGEMENT BOARD AND THE TECHNICAL WORKING GROUP BASED ON THE IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT 9003.**

**WHEREAS**, there is an existing Municipal Ecological Solid Waste Management Board of Itogon previously organized during the past administration;

**WHEREAS**, there is a need to reorganize the membership of the Board in the context of a new administration and the urgent need to facilitate the implementation and monitoring of the Municipal Ecological Solid Waste Management Plan;

**NOW, THEREFORE I, VICTORIO T. PALANGDAN**, Municipal Mayor of Itogon, by virtue of the powers vested in me by law, hereby reorganize the Ecological Solid Waste Management Board of Itogon and the Technical Working Group thereof with the following composition:

**Section 1. Composition**

- b.) Adopts measures to promote and ensure the viability and effective implementation of solid waste management programs in all component barangays.
- c.) Monitor the implementation of the Municipal Ecological Solid Waste Management Plan through the component barangays, and in cooperation with concerned NGO's
- d.) Adopts specific revenue- generating measures to promote the viability of the Ecological Solid Waste Management Plan.
- e.) Convenes regular meetings for purpose of planning and coordinating the implementation of the Ecological Solid Waste Management Plan of component barangays.
- f.) Oversees and reviews every two (2) years, or as the need arises, the Municipal Ecological Solid Waste Management Plan for the purposes of ensuring its sustainability, viability, effectiveness and relevance in relation to local and international developments in the field of Ecological Solid Waste Management.
- g.) Develops specific mechanics and guidelines to implement the MESWMB's plan
- h.) Recommends to appropriate local government authorities the specific measures or proposals for franchise or build –operate-transfer agreements with recognized institutions to provide either exclusive or non-exclusive authority for the collection, transfer, storage, processing, recycling, or disposal of municipal solid waste.
- i.) Provides the necessary logistical and operational support to component barangays.
- j.) Recommends measures and safeguards against pollution and preservation of natural ecosystem.
- k.) Coordinates the efforts of component barangays in the implementation of the plan.
- l.) Call on any concerned agency or sector as it may deem necessary for support or other appropriate action.


The function of the Technical Working Group is to assist the Municipal Ecological Solid Waste Management Board in the implementation of the Municipal Ecological Solid Waste Management Plan.
