AMENDING CERTAIN PROVISION OF ADMINISTRATIVE ORDER NUMBERED 09-13-N PARTICULARLY THE COMPOSITION OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF ITOGON.

WHEREAS, the Municipal Disaster Risk Reduction and Management Council was reorganized by virtue of Administrative Order No. 09-13-N dated July 12, 2013 in accordance with the pertinent provisions of R.A. 10121 or the Disaster Risk Reduction Management Act of 2010;

WHEREAS, there is a need to fill up vacancies in the composition of the reorganized MDRRMC due to transfer of assignment of former members from Itogon to other municipalities, retirement or separation from public service, incapacity to represent the organization, and for such other reasons;

WHEREAS, consistent with the express provisions of RA 10121 empowering Local Government Units, the private sector and the Civil Society Organizations as key partners in disaster risk reduction, it is wise enough to consider the inclusion of interested sectors to the MDRRMC who have expressed their commitment and willingness to work hand in hand with the municipal government as far as disaster risk reduction and management is concerned;

NOW THEREFORE by virtue of the powers vested in me as Municipal Mayor of the Municipality of Itogon, I, **VICTORIO T. PALANGDAN** hereby amend certain provisions of Administrative Order No. 09-13-N particularly the composition of the Municipal Disaster Risk Reduction and management Council (MDRRMC) of the Municipality of Itogon which shall be as follows:


