**ESTABLISHING THE OFFICE OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT AS PERSONS WITH DISABILITIES ASSISTANCE OFFICE (PDAO)**

**WHEREAS**, the Persons with Disabilities (PWDs) due to various restrictions in their abilities are arguably the most disadvantaged sector in the society for most of them lacked the educational attainment necessary for self-advancement;

**WHEREAS**, the Local Government Unit shall promote the establishment of the organization of Persons with Disabilities (PWDs) in their respective territorial jurisdiction to provide assistance to differently abled persons;

**WHEREAS**, Republic Act No. 10070, otherwise known as "An act establishing an institutional mechanism to ensure the implementation of programs and services for Persons with Disabilities in every province, city and municipality, amending Section 40 of Republic Act No. 7277, otherwise known as Magna Carta for Disabled Persons" as amended, and for other purposes, a Persons with Disability Affairs Office (PDAO) shall be organized and established in every province, city and municipality;

**WHEREAS**, in September 23, 2010, the Department of Interior and Local Government issued Memorandum Circular No. 2010-2013 mandating the establishment of Persons with Disabilities Affairs Office (PDAO) in every Province, City and Municipality pursuant to RA 10070;

**WHEREAS**, the Honorable members of the Sangguniang Bayan has passed Resolution Numbered 372,s.2014, recommending the establishment of an institutional mechanism to ensure the implementation of programs and services for PWDs in the municipality;
