ADMINISTRATIVE ORDER NO. 15-32 Series of 2015

## AN ADMINISTRATIVE ORDER IN SUPPORT TO NATIONAL DISABILITY PREVENTION AND REHABILITATION (NDPR) WEEK THROUGH THE ESTABLISHMENT OF PERSON WITH DISABILITY (PWD) CENTER/FACILITY

WHEREAS, this Municipality strongly supports and prioritizes the rights of Person with Disabilities (PWDs) in support to Batasang Pambansa 344 entiltled AN ACT TO ENHANCE THE MOBILITY OF DISABLED PERSONS BY REQUIRING CERTAIN BUILDINGS, INSTITUTIONS, ESTABLISHMENTS AND PUBLIC UTILITIES TO INSTALL FACILITIES AND DEVICES, wherein this Municipality shall establish the PWD Center/ Facility and other assistive devices;

WHEREAS, every July of each year is slated for the national Disability Prevention and Rehabilitation Week and for this year CY 2015 marked the 27<sup>th</sup> NPPR Year's Anniversary which aims to stimulate public awareness on the issues and concerns of disability, thereby encouraging every citizen of the country to take active participation in the economic, health and social development of the PWDs. This year theme "IHealth and Wellness of PWDs, Opportunities Towards Inclusive Development for All";

WHEREAS, in support to such, synchronize activities of PWDs that a sociocivic center/facility devoted to PWDs is hereby established to cater to the activities and harness full potential of PEDs as active partners of socio-economic development and/or nation building;

WHEREAS, the LGU through the MHO and MSWDO, Constituency and PWDs are the primary key stakeholders in making sure that equal rights and nondiscriminatory environment are accorded to PWDs in the locality;

WHEREAS, the establishment of PWD/PDAO facility to be located at the FIANZA Memorial Hall shall be manned by PWD Officers and staff with corresponding budgetary support from the Mayor's Office to accommodate;

- -1 PWD officer of the Day
- -1 Secretary/ Records Officer

WHEREAS, such center/ facility shall be all purpose center for PWDs that would cater to their needs and aspirations, as they could avail services from the different offices. The center with services to accommodate them at the center, the center could be further described as:

**PWD** Center as

A center of excellence for PWD Fastlane;

- A center of planning;
- A socio-civic Center;

A PWD friendly Center wherein basic LGU frontline services are provided within reach and reasonable time; WHEREAS, such innovation is in support to good governance agenda and being true to its theme: " Excel and be Distinct" through socially protective measures i.e. a PWD Friendly Municipality;

WHEREAS, the different Offices of this Municipality are hereby required to provide an on call action officer to attend to the needs of PWD at the Center, to wit:
