## ADMINISTRATIVE ORDER NO. 06

CREATING A MUNICIPAL PROJECT COORDINATING UNIT FOR THE IMPLEMENTATION OF THE SAFE PROJECT ON PHILIPPINE NATIVE ANIMALS FOR DISASTER RISK REDUCTION IN HAZARD-PRONE AREAS OF BENGUET (SAFE-PNADRRHAB).

WHEREAS, the Department of Science and Technology-Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (DOST-PCAARRD) has provided funding for the SAFE-PNADRRHAB Project which is being implemented by Benguet State University;

WHEREAS, the Municipality of Itogon is a recipient of the afore-mentioned project which aims to strengthen the capacity of BSU and the LGU as reliable sources of livestock for distribution to disaster-prone communities in Itogon during emergencies and recovery, and to promote native animal raising as part of integrated disaster risk reduction and management program in preparation for future disasters while simultaneously conserving local livestock;

NOW THEREFORE I, ATTY. VICTORIO T. PALANGDAN, by virtue of the powers vested in me by law as Municipal Mayor of Itogon, Benguet, hereby ORDER as follows:

Section 1. A Municipal Coordinating Unit for the SAFE Project on Philippine Native Animals for Disaster Risk Reduction in Hazard-Prone Areas of Benguet is hereby created and shall be composed of the following:

Section 2. The Municipal Coordinating Unit shall perform the following functions:

- 1. Identify farmer cooperators based the criteria set forth by Benguet State University;
- 2. Facilitate the conduct of farmers trainings, meetings and field demonstrators and ensure participation of all cooperators thereto;
- 3. Closely coordinate with Benguet State University and shall assist the latter in the implementation of the project;
- 4. Closely monitor the project and shall report to the LCE and BSU its findings, observations and recommendations;
- 5. Perform other related functions necessary and incidental to ensure project sustainability.

Section 3. This Order shall take effect immediately.
