**ADMINISTRATIVE ORDER NO. 20**  
Series of 2019

**REORGANIZING THE DIFFERENT TASK FORCES CREATED AND ORGANIZED UNDER THE MDRRMC, PURSUANT TO ADMINISTRATIVE ORDER NO. 22, SERIES OF 2018.**

**WHEREAS**, to fast track post disaster recovery and rehabilitation initiatives due to the devastating effects of Typhon Ompong that hit the locality last September 15, 2018, the Local Chief Executive issued Administrative Order No. 22, series of 2018 creating various Task Forces to perform corresponding duties and functions relative to housing, resettlement, livelihood and employment;
