



ADMINISTRATIVE ORDER NO. 37

ORGANIZING THE MUNICIPAL ASSESSMENT TEAM FOR THE SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAYS (SGLGB) IN THE MUNICIPALITY OF ITOGON.

WHEREAS, the Department of the Interior and Local Government included the barangays in the Seal of Good Local Governance program to encourage barangays to scale up its performance and practices of good governance that accord primary to the principles of accountability, transparency, performance and effectiveness;

WHEREAS, in pursuance of the SGLGB program, the DILG issued Memorandum Circular No. 2018-194, the purpose of which is to institutionalize a system of recognition and incentive awards for barangay government and to provide mechanics for possible access to the Performance Challenge Fund (PCF) and other incentive mechanisms available;

WHEREAS, aforementioned Memorandum Circular requires the creation of a Municipal Assessment Team for the SGLGB Program;

WHEREFORE, by virtue of the powers vested in me by law, I, **ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby organize and designate the members of the Municipal Assessment Team for the Seal of Good Local Governance for Barangays (SGLSB), to wit;

Section 1. Composition. The Municipal Assessment Team for SGLGB shall be composed of the following:

Section 2. Functions. The Municipal Assessment Team shall perform the following functions:


1. Shall be responsible in collecting data for the SGLGB from the barangays;
2. Shall conduct validation and certification through documentary review, interview and onsite inspection to ensure reliability and quality of data;

3. Through the SGLGB Focal Person, shall input data in the SGLGB online database.
4. Perform other functions in relation to the implementation of the SGLG for Barangays program as may be directed by the DILG, and other concerned authorities.

Section 3. *Repealing Clause.* All Executive Orders and/or Issuances inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

Section 4. *Effectivity.* This Administrative Order shall take effect immediately.
