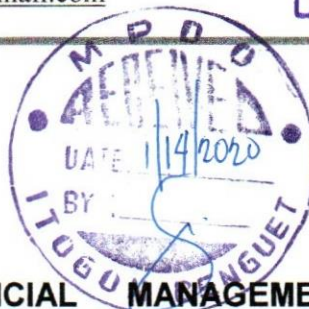

REORGANIZING THE PUBLIC FINANCIAL MANAGEMENT AND IMPROVEMENT PLAN (PFMIP) TEAM OF THE MUNICIPAL LOCAL GOVERNMENT OF ITOGON.

WHEREAS, public financial management is an integral part of an organization structure and operating mechanisms as it provides the general framework for generating revenues, allocating resources and managing expenditures which are all necessarily entailed in the fulfillment of the mandates of Local Government Units;

WHEREAS, public financial management seeks to address key challenges of controlling government spending and making agencies operate efficiently and effectively;

WHEREAS, by virtue of Executive Order No.3, series of 2014 issued by the Local Chief Executive, the Public Financial Management Team as a component of the PFMAT was created and constituted in accordance with the Manual of PFMAT for LGUs issued by the Department of Budget and Management;

WHEREAS, considering the need for an effective and efficient implementation of the Public Financial Management and Improvement Plan of the municipality which was developed under the Public Financial Management Assessment System, the PFMIP Team was created by virtue of Administrative Order No. 17, series of 2017.

NOW THEREFORE, by virtue of the powers vested in me as Municipal Mayor of the Municipality of Itogon, I ATTY. VICTORIO T. PALANGDAN hereby re-organize the Public Financial Management and Improvement Plan (PFMIP) Team of the Local Government of Itogon to be composed of the following:

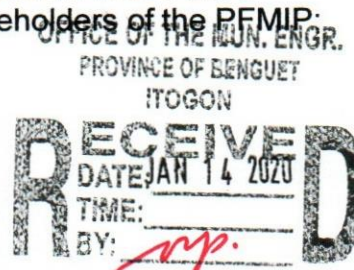
Section 2. *Duties and Functions.* The PRMIP Team shall perform the following duties and functions:
