AMENDING THE COMPOSITION OF THE MUNICIPAL PEACE AND ORDER COUNCIL AND THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL TO INCLUDE MR. OSWALDO C. CALLOS IN THE MEMBERSHIP THEREOF AS ONE OF THE CIVIL SOCIETY ORGANIZATION REPRESENTATIVES, AND FOR THE INCLUSION IN EACH BODIES OF PMAJ DEXTER A. SIMON, CHIEF OF POLICE OF THE ITOGON MUNICIPAL POLICE STATION IN LIEU OF PMAJ ROMMEL P. SAWATANG.

WHEREAS, by virtue of MPOC Resolution No. 2019-01, the Municipal Peace and Order Council was reorganized, the composition and membership of which was adopted in accordance with the guidelines and procedures set forth under DILG Memorandum Circular No. 2019-143;

WHEREAS, on the other hand, the Municipal Anti-Drug Abuse Council was also reorganized by virtue of Administrative Order No. 20, series of 2020 in accordance with the mandate provided under the Local Government Code for LGUs to pursue undertakings that would improve public morals and maintain peace and order among other equally significant concerns (Sec. 16, LGC) and such other related laws, guidelines and policies;

WHEREAS, LGUs are likewise mandated under the Local Government Code to pursue undertakings that would improve public morals and maintain peace and order among other equally significant concerns (Sec. 16, LGC);

WHEREAS, the membership of CSO representative is common among all local special bodies and other councils created for specific purposes pursuant to the constitutional provisions that seeks to promote and protect the rights of the people and civil society organizations to effectively and reasonably participate at all levels of social, political and economic decision-making;

WHEREAS, the inclusion of Mr. Oswaldo C. Callos as member of both the MPOC and the MADAC was approved by the members concerned during the joint MPOC-MIATF and MADAC meeting held on February 16, 2021 at the Municipal Function Hall;

WHEREAS, the appointment of PMaj Dexter A. Simon as new Chief of Police of the Itogon Municipal Police Station in lieu of PMaj Rommel P. Sawatang also necessitates an amendment in the membership of both the MPOC and the MADAC in order to fill up the vacancy created due to the change of command in the IMPS;

NOW THEREFORE, by virtue of the powers vested in me, I, **ATTY. VICTORIO T. PALANGDAN**, in my capacity as Municipal Mayor of Itogon, Benguet Province, hereby Order as follows:

Section 1. <u>Composition of the Municipal Peace and Order Council.</u> The existing members of the Municipal Peace and Order Council re-organized by virtue of MPOC Resolution No. 01-2019 shall remain except for PMAJ ROMMEL P. SAWATANG who shall be replaced by PMAJ DEXTER A. SIMON due to the change of command in the Itogon Municipal Police Station.

Provided further, that PTR. OSWALDO C. CALLOS of Yeshua Change Agents shall be included in the membership of the MPOC as CSO representative. Aside from being a regular member of the MPOC, Ptr. Oswald C. Callos will also be a member of the MPOC Special Action Committee on Anti-Criminality.

Section 2. <u>Composition of the Municipal Anti-Drug Abuse Council.</u> The existing members of the Municipal Anti-Drug Abuse Council re-organized by virtue of Administrative Order No. 20-2020 shall remain except for PMAJ ROMMEL P. SAWATANG who shall be replaced by PMAJ DEXTER A. SIMON due to the change of command in the Itogon Municipal Police Station.

Provided further, that PTR. OSWALDO C. CALLOS of Yeshua Change Agents shall be included in the membership of the Municipal Anti-Drug Abuse Council as additional CSO representative.

Section 3. <u>Repealing Clause.</u> All Administrative Orders or parts thereof inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

Section 4. Effectivity. Order shall take effect immediately.
