CREATING THE MUNICIPAL MONITORING TEAM FOR THE ENFORCEMENT OF MUNICIPAL ORDINANCE NO. 51,S.2021, ENTITLED "AN ORDINANCE PROVIDING FOR POLICY GUIDELINES REGULATING THE ENTRY AND INFORMAL SETTLEMENT OF NON-CONSTITUENT OF ITOGON WITHIN THE COMPONENT BARANGAYS OF THE MUNICIPALITY OF ITOGON, PROVINCE OF BENGUET"

Whereas the Sangguniang Bayan enacted Ordinance No. 51, s.2021, entitled "AN ORDINANCE PROVIDING FOR POLICY GUIDELINES REGULATING THE ENTRY AND INFORMAL SETTLEMENT OF NON-CONSTITUENT OF ITOGON WITHIN THE COMPONENT BARANGAYS OF THE MUNICIPALITY OF ITOGON, PROVINCE OF BENGUET";

Whereas under Section 6 of the above-stated ordinance, the Local Chief Executive is mandated to constitute a team to closely monitor the implementation of the said ordinance;

Now therefore, by virtue of the powers vested in me by law and pursuant to Municipal ordinance No. 51, s.2021, I, Atty. VICTORIO T. PALANGDAN, Local Chief Executive of this municipality, do hereby issue this Administrative Order creating the Municipal Monitoring Team for the enforcement of Municipal Ordinance No. 51,s.2021 as follows:

Section 1. Composition. The Municipal Monitoring Team shall be composed of the following:

Section 4. Functions. The functions of the monitoring team shall be based on the pertinent provisions of Ordinance No. 51,s.2021.

Section 5. Effectivity. This Order shall take effect immediately.
