# CREATING THE EXECUTIVE COMMITTEE AND TECHNICAL WORKING GROUP TO DRAFT THE PROPOSED AMENDMENTS TO THE 2016 REVISED REVENUE CODE OF THE MUNICIPALITY OF ITOGON

Whereas Section 191 of the Local Government Code (LGC) of 1991 states that local government units shall have the authority to adjust tax rates as prescribed in the LGC not oftener than once every five (5) years, but in no case shall such adjustment exceed ten percent (10%) of the rates fixed by the LGC;

Whereas the Sangguniang Bayan of Itogon requested for the creation of an Executive Committee and a Technical Working Group (TWG) to draft the proposed amendments to the 2016 Revised Revenue Code with recommendation on their composition;

Now therefore, by virtue of the powers vested in me as the Local Chief Executive of the Municipality of Itogon, I, ATTY. VICTORIO T. PALANGDAN, do hereby create the Executive Committee and Technical Working Group (TWG) to draft the proposed amendments to the 2016 Revised Revenue Code of the Municipality of Itogon to be composed by the following:
