ADMINISTRATIVE ORDER NO. <u>17</u> Series 2021

CREATING THE TECHNICAL WORKING GROUP (TWG) FOR THE ITOGON MUNICIPAL OVERSIGHT COMMITTEE ON REVISION OF FEES AND CHARGES

Whereas on August 12, 2020, the Itogon Municipal Oversight Committee on Revision of Fees and Charges was created to ensure that the guiding principles as prescribed in the Local Government Code (LGC) and DILG-DOF JMC 2019-01 are observed;

Whereas in order for the aforementioned committee to serve its purpose, a technical working group was recommended to aid in the carrying-out of the committee's functions;

Now therefore, by virtue of the powers vested in me as the Local Chief Executive of the Municipality of Itogon, I, ATTY. VICTORIO T. PALANGDAN, do hereby create the Technical Working Group (TWG) for the Itogon Municipal Oversight Committee on Revision of Fees and Charges to be composed by the following with their identified functions:

- Gather data on the cost of delivering regulatory, service fees, and charges imposed by the Municipal Government of Itogon;
- b. Compute the appropriate rates that will recover the cost, using the prescribed Local Fees and Charges (LFC) Toolkit;
- c. Submit report on the accomplished aforementioned tasks (a & b) to the Itogon Municipal Oversight Committee on Revision of Fees and Charges before December 31, 2021.

SECTION 3. EFFECTIVITY. This Executive Order shall take effect immediately.
