ADMINISTRATIVE ORDER NO. 18

DESIGNATING MR. ARNEL F. BAHINGAWAN AS MEMBER OF THE DIFFERENT LOCAL SPECIAL BODIES, COMMITTEES, COUNCILS, BOARDS AND SUCH OTHER BODIES CREATED UNDER THE MUNICIPAL GOVERNMENT WHERE THE MUNICIPAL ADMINISTRATOR IS A MEMBER THEREOF IN LIEU OF ATTORNEY NOEL G. NGOLOB WHO WAS SEPARATED FROM OFFICE BY REASON OF HIS FILING OF CERTIFICATE OF CANDIDACY FOR THE 2022 NATIONAL AND LOCAL ELECTIONS.

WHEREAS, a vacancy occurred in the membership in different local special bodies, committees, councils, boards, etc. which were created and/or established under the municipal government due to the resignation of Atty. Noel G. Ngolob arising from his filing of his Certificate of Candidacy for the 2022 National and Local Elections;

WHEREAS, in lieu of Atty. Noel G. Ngolob, the undersigned Local Chief Executive appointed Mr. Arnel F. Bahingawan as Municipal Administrator of the Municipality of Itogon effective October 11, 2021;

WHEREAS, the vacancies arising from the separation of Atty. Noel G. Ngolob from government service necessitate the immediate designation of his successor as member of the various local bodies, committees, boards, and the like, to prevent delay in the delivery of related government services and to ensure continuity in the execution of functions appurtenant thereto;

NOW THEREFORE, by virtue of the powers vested in me, I, ATTY. VICTORIO T. PALANGDAN, in my capacity as Municipal Mayor of Itogon, Benguet Province, hereby ORDER as follows;

Section 1. In the exigency of services for the public good, MR. ARNEL F. BAHINGAWAN, Municipal Administrator of Itogon is hereby designated as member of the different Local Special Bodies, Boards, Committees and such other bodies created under the Municipal Government where the Municipal Administrator is among its members;

Section 2. the position of the Municipal Administrator in Local Special Bodies, Committees, Councils, and Boards duly created shall remain unless provided otherwise under existing laws, or unless a reorganization shall take place by virtue of an ordinance or through a subsequent order to be issued by the undersigned;

Section 3. All Administrative Orders or parts thereof inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

Section 4. This Administrative Order shall take effect immediately.
