REORGANIZING THE MUNICIPAL ASSESSMENT TEAM FOR THE SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAYS (SGLGB) IN THE MUNICIPALITY OF ITOGON.

WHEREAS, the Department of the Interior and Local Government included the barangays in the Seal of Good Local Governance program to encourage barangays to scale up its performance and practices of good governance that accord primary to the principles of accountability, transparency, performance and effectiveness;

WHEREAS, in pursuance of the SGLGB program, the DILG issued Memorandum Circular No. 2018-194, the purpose of which is to institutionalize a system of recognition and incentive awards for barangay government and to provide mechanics for possible access to the Performance Challenge Fund (PCF) and other incentive mechanisms available:

WHEREAS, in compliance with the aforementioned Memorandum Circular, a Municipal Assessment Team for the SGLGB Program was organized by virtue of Administrative Order No. 37, series of 2019 however, a reorganization is needed to fill the vacancies arising from the separation of some members;

WHEREFORE, by virtue of the powers vested in me by law, I. ATTY. VICTORIO T. PALANGDAN, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby reorganize the Municipal Assessment Team for the Seal of Good Local Governance for Barangays (SGLGB), to wit;
