CREATING THE TEAM RESPONSIBLE FOR THE RESEARCH AND PREPARATION OF THE NECESSARY DOCUMENTS IN THE BOUNDARY DISPUTE OF THE MUNICIPALITY OF ITOGON WITH THE MUNICIPALITY OF TUBA AND THE MUNICIPALITY OF BOKOD

WHEREAS, the undersigned engaged the services of Mr. Aloysius G. Kato to be part of the Municipal Team that would pursue actions for a peaceful conflict resolution with the neighboring municipalities;

WHEREAS, the purpose of which is to finally resolve boundary disputes with other municipalities in a peaceful and boundary manner with terms and conditions acceptable to all parties;

WHEREAS, Mr. Aloysius G. Kato duly accepted the duties and responsibilities to represent the Municipality of Itogon regarding the boundary dispute between the Municipality of Itogon, Tuba, and Bokod;

WHEREAS, the Sangguniang Bayan of the Municipality gave an authority to Mr. Aloysius G. Kato which includes the termination of the amicable settlement with the Municipality of Bokod in case 2014-02 filed before the Sangguniang Panlalalwigan of Benguet and for the trial to ensue before the latter;

NOW THEREFORE, by virtue of the power vested in me, **I, VICTORIO T. PALANGDAN**, Municipal Mayor, of Itogon, Benguet Province hereby promulgate as follows:

Section 1. There is hereby created the Team and Technical Working Group, Responsible for the Research and Preparation of the necessary documents in the boundary dispute to be composed of the following;
