**ADMINISTRATIVE ORDER NO. 03** Series of 2022

DESIGNATING MR. DENNIS A. TAMPOA, COMPUTER PROGRAMMER III, AS FOCAL PERSON ON TELECOMMUNICATION PERMIT ONLINE MONITORING SYSTEM (TELPOMS).

WHEREAS, slow internet speed and limited connectivity in the country is a major concern which the Duterte administration seeks to address in order to ensure business continuity, household sustainability and peoples accessibility to various services;

WHEREAS, President Rodrigo Roa Duterte directed the telecommunications sector to upgrade and fast track the digital infrastructure, and the Department of the Interior and Local Government to undertake additional measures to support the construction of PTTIs in the country by auditing LGUs with pending applications on telecommunications tower infrastructure:

WHEREAS, amid the pandemic, the government is committed to provide assistance to the TelCos in their infrastructure build-up by expediting the approval of tower permits as a measure to improve internet services resulting into quality internet speed and connectivity at affordable prices which, in effect shall make feasible the conduct of work from home, on-line learning and on-line business, boost government's covid-19 response and finally, to enable the country to adopt to the new normal;

WHEREAS, to accelerate the roll-out of telecommunication infrastructure and service projects, the ARTA, DICT, DILG, DHSUD, DPWH, CAAP, DOH and FDA issued Joint Memorandum Circular No. 2020-01 titled "Streamlined Guidelines for the Issuance of Permits, Licenses and Certificates for the Construction of Shared Passive Telecommunications Tower Infrastructures (PTTIs):

WHEREAS, DILG Memorandum Circular No. 2021-116 directs the designation of a Focal Person on Telecommunication Permit Online Monitoring System (TELPOMS) of the Local Government Unit;

NOW THEREFORE, by virtue of the powers vested in me, I, ATTY. VICTORIO T. PALANGDAN, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby ORDER as follows;

Section 1. Mr. Dennis A. Tampoa, Computer Programmer III under the Office of the Municipal Mayor is hereby designated as LGU Focal Person on Telecommunication Permit Online Monitoring System (TELPOMS);

Section 2. The Focal Person shall perform the following functions:

 Gather and collect from the Office of the Building Official and the Business Permits and Licensing Officer their duly accomplished Pending and Approved PTTI Application Monitoring and Evaluation Form 1 on a daily basis, and Fast Tracking PTTI Application M&E Form 2 on a semi-weekly basis (every Tuesday and Friday of the week until 3:00 PM);

 Shall monitor and ensure that the operations of telecommunication companies in constructing, repairing, installing, maintaining and other activities will not be hampered and be fully operational;

**Section 3.** Responsibilities of the Office of Building Official and the BPLO: The OBO and the BPLO shall be responsible in accomplishing the following forms:

- a. Approved and Pending PTTI Application M&E Form 1 on a daily basis, and
- b. Fast-tracking PTTI Application M&E Form 2 on a semi-weekly basis.

Section 4. This Order shall take effect immediately.
