REORGANIZING THE MUNICIPAL LUPONG TAGAPAMAYAPA INCENTIVES AWARDS COMMITTEE.

WHEREAS, the Lupong Tagapamayapa Economic and Incentives Awards Program of the Department of the Interior and Local Government was established pursuant to Section 406(b) of the Local Government Code of 1991 in recognition of the exemplary performance of the Lupong Tagapamayapa of a certain barangay which had significantly contributed to the attainment of the objectives of the Katarungang Pambarangay;

WHEREAS, DILG Memorandum Circular No. 2023-022 dated February 08, 2023 provided for an amended guidelines on the Lupong Tagapamayapa incentives awards and enhanced incentives criteria and guidelines, expressly repealing DILG Memorandum Circular Numbers 2004-43, 2008-102 and 2016-058, further amending the composition of the different awards committee;

WHEREFORE, by virtue of the powers vested in me by law, I. HON. BERNARD S. WACLIN, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby reorganize the Municipal Lupong Tagapamayapa Incentives Awards Committee as follows:

(b) *Provided further,* that in case that the Lupon to be assessed is headed by the Liga President, the latter shall inhibit and designate the next-in-rank officer of the LnB Municipal Chapter.

Section 2. Functions:

 Initiate and coordinate the necessary activities towards the successful implementation of the LTIA in the municipality;

- 2. Disseminate information on the awards to generate awareness and support from the public and private sector;
- 3. Select and submit to the PAC the best performing Lupons within the municipality;
- 4. Generate counterpart funds for prizes from partner agencies and the private sector; and
- 5. Plan and implement appropriate awarding ceremonies.

Provided further, that the DILG Municipal Field Office shall provide technical and secretariat services to the MLTIA Committee.

Section 3. Repealing Clause: All Administrative Orders or parts thereof which are inconsistent with this order or parts hereof are deemed repealed or modified accordingly.

Section 4. Effectivity. This Administrative Order shall take effect immediately.
