REORGANIZING THE CITIES AND MUNICIPALITIES COMPETITIVENESS INDEX TEAM (CMCI TEAM) OF THE MUNICIPALITY OF ITOGON, AMENDING ADMINISTRATIVE ORDER NO. 02, SERIES OF 2023.

WHEREAS, the Cities and Municipalities Competitiveness Index (CMCI) is an annual ranking of Philippine cities and municipalities, anchored on five pillars which are: Economic Dynamism; Government Efficiency; Infrastructure; Resiliency; and Innovation;

WHEREAS, the Index can be used by (a) local government officials as diagnostic tool to identify areas for improvement and as a guide for policy-making, development planning and investment promotion;(b) by the private sector as guide for business community in deciding where to locate; and (c) by the academe, CSOs and tourists as a take-off point for further researches;

WHEREAS, the CMCI Team of the municipality has been organized as a unit to accomplish various tasks and assignments involved in the CMCI Survey such as collection of appropriate data from both the government and the private sector, verification of information, coordination with appropriate agencies, submission of requirements to assigned enumerators, and the like;

WHEREAS, there is a need to reorganize the CMCI Team created by virtue of Administrative Order No. 2, series of 2023 to be in conformity with the recommendation of the Department of Trade and Industry that the CMCI Survey shall be lodged to the Municipal Planning and Development Office which has the mandatory function of gathering socio-economic data from all sectors and the available resources that may be utilized in the said project;

**NOW THEREFORE**, by virtue of the powers vested in me as Municipal Mayor of the Municipality of Itogon, I, **BERNARD S. WACLIN** hereby re-organize the Cities and Municipalities Competitiveness Index Team (CMCI Team) of the Municipality of Itogon as follows:
