Whereas on March 01, 2011, Administrative Order No. 32, Series of 2011 was street laying down the guidelines for the Municipal Government of Itogon on Personnel Relection and 2023 Promotion;

Whereas on November 11, 2016, Administrative Order No. 34, Series of 2016 was issued amending the guidelines on Personnel Selection and Promotion as laid down Administrative Order No. 32, Series of 2011;

Wheleas Administrative Order No. 34-A, Series of 2016 was further issued amending Administrative Order No. 32, Series of 2011 to embody recent updates ecommendations from the Personnel Selection Board (PSB) of the municipဖွံ့l inment;

Whereas Administrative Order No. 21, Series of 2020 was issued on July 21, 2026 ammding Administrative Order No. 34-A, Series of 2016 providing for updated guidelines on Personnel Selection and Promotion;

Whereas guided by issuances from the Civil Service Commission (CSC) and as local government units are encouraged by the CSC to institutionalize meritocracy and excellence in all areas such as recruitment, selection, and placement, there is a need to reestablish the guidelines for personnel selection and promotion in order to carry out the recommendations from the present Personnel Selection Board (PSB) to properly give dredence or merit to the different criteria achieved by every qualified applicant;

Now, therefore, by virtue of the powers vested in me by law, I, BERNARD S. WACLIN Municipal Mayor of the Municipality of Itogon, Benguet Province, do hereby re-estations the Guidelines on Personnel Selection & Promotion for the Municipal Governg Itogon as follows: DATE: MAY 16 2023

SECTION 1. COVERAGE. The following re-established guidelines shall be used present and succeeding selection process.
