Section 1. Composition: The Municipal Clean and Green Committee is hereby reorganized and shall be composed of the following:

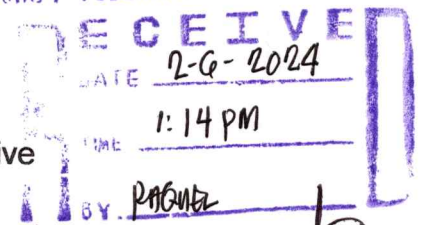





The Punong Barangay or School Head or representative of any participating barangay, school or other institutions respectively in case of national, regional and/or provincial competitions.

Section 2. Duties and Functions. The Municipal Clean and Green Committee shall perform the following functions:

1. Shall act as front liner in the implementation of clean, green and bloom programs and activities of the national and provincial governments at the local level;
2. Shall formulate plans and adopt strategies to maintain clean and green environment including the conduct of a municipal-wide clean up drives along the roads, rivers, public places such as plazas, parks, courts, etc.;
3. Shall manage funds allocated from available sources for the implementation of PPAs related to clean and green such as regular clean-up drives along roads, rivers, public places, tree planting activities and programs on awards and incentives subject to regular auditing rules and the pertinent provisions of R.A. 9184;

4. Formulate and recommend to the Local Chief Executive program on awards and incentives in recognition of a community, barangay or institutions that demonstrate exemplary undertakings towards the promotion of a clean, healthy and green environment;
5. Provide technical and administrative support to participating barangays, schools, and other institutions in any provincial, regional and national clean and green competitions and such similar competitions organized by public or private entities;
6. Assist representatives of the National and/or Provincial Government and other public or private entities during assessment and evaluation on the performance/compliance of barangays, schools, or the municipality to directives or programs and activities on clean, green and bloom including road side beautification programs; and
7. Perform such other duties and functions pursuant to law or ordinance, or as may be directed by the Local Chief Executive.
