ADMINISTRATIVE ORDER NO. 6

DESIGNATING PUNONG BARANGAY PAUL M. CAMANTILES AND MS. DAISY B. CHARONGEN AS MEMBERS OF THE PEOPLES LAW ENFORCEMENT BOARD OF THE MUNICIPALITY OF ITOGON IN LIEU OF P.B. EDWIN O. ATUMPAG AND ENGR. MICHAEL G. TAULI, RESPECTIVELY.

WHEREAS, the Peoples Law Enforcement Board of the Municipality of Itogon was reorganized by virtue of Administrative Order No. 47, series of 2022, which members include Engineer Michael G. Tauli and Punong Barangay Edwin O. Atumpag;

WHEREAS, the appointment of Engr Michael G. Tauli as Executive Assistant II under the Office of the Local Chief Executive, and the nomination of P.B. Paul M. Camantiles as representative of the Liga to the PLEB through Liga Resolution No. 2, series of 2024 necessitate the designation of new members to said body;

WHEREAS, a valid cause has been established hence, the need to designate new members to fill the positions vacated by Engineer Michael G. Tauli and Punong Barangay Edwin O. Atumpag;

NOW THEREFORE, by virtue of the powers vested in me as Municipal Mayor of Itogon, Benguet, and as the Chairman of the Municipal Peace and Order Council, I, **BERNARD S. WACLIN**, hereby ORDER As follows:

Section 1. <u>Designation of New Members of the PLEB:</u> Punong Barangay Paul M. Camantiles and Ms. Dasy B. Charongen are hereby designated as members of the People's Law Enforcement Board of the Municipality of Itogon in lieu of P.B. Edwin O. Atumpag and Engineer Michael G. Tauli, respectively. Said P.B. Paul M. Camantiles and Ms Daisy B. Charongen shall serve the unexpired term of their predecessors unless their designation is sooner revoked, cancelled or terminated for reasons authorized by law.

Section 2. Repealing Clause. All Administrative Orders and executive issuances inconsistent with this ORDER or parts hereof are deemed repealed or modified accordingly.

Section 3. Effectivity. This Order shall take effect immediately.
