EXECUTIVE ORDER NO. <u>005</u> Series of 2013

AMENDING EXECUTIVE ORDER NO. 04-s.2013 RE: IMPLEMENTING RULES AND REGULATIONS (IRR) OF MUNICIPAL ORDINANCE NO. 39, 2012 AMENDING ONLY ORD. NO. 03-S.2001

WHEREAS, Executive Order No. 04, series of 2013 re: implementing Rules and Regulations (IRR) of Municipal Ordinance No. 39, series of 2012 amending Municipal Ordinance 03, series of 2001, was approved on the 15th day of April, 2013;

WHEREAS, in the said Executive Order, the cash prizes for some categories were erroneously entered, not reflecting what was duly approved under Municipal Ordinance No. 39, series of 2013;

WHEREAS, there is a need to rectify by way of amendment the erroneously entered cash prizes under Executive Order No. 04, series of 2013, so as to reconcile said item provisions with that of Municipal Ordinance No. 39, series of 2012;

WHEREAS, there is also a need to identify the official agency who shall issue the certification as basis for the availment and release of the cash incentives to be awarded to qualifying sports and skills competition winners;

NOW THEREFORE, I, OSCAR MAINGPES CAMANTILES, Municipal Mayor of Itogon, by virtue of the powers and authority vested upon me by law do hereby amend the previously issued Executive Order by rectifying the erroneously entered cash prizes as contained in the previously issued Executive Order No. 04-s.2013 and to identify the official agency to issue certification as basis of this LGU to award the cash incentive to the qualified students.

RULE I. GENERAL PROVISIONS

Section 1. Short Title: This Implementing Rules and Regulations, hereinafter called the IRR, is promulgated pursuant to Section 444, par. b (2.iii) of the Local Government Code of 1991.

Section 2. Purpose: This IRR is issued for the purpose of prescribing the necessary rules and regulations for the efficient and more realistic enforcement of Municipal Ordinance No. 39, 2012 as amended on the grant of financial incentive awards to medal/trophy winners and their coaches in sports, skills and academics;

RULE II .DEFINITION OF TERMS:

Section 1. International Competition: It refers to any event/activity regardless of the venue ---a forum beaming an international character or nature and participated in not only by Filipinos but also by delegates from other countries;

Section 2. National Competition. It means any event/activity held in any venue or place within the territorial jurisdiction of the Philippines and participated in by representatives from different organizations as sanctioned by the government through any recognized government agency;

Section 3. Regional Competition: It is defined as any event/activity held within the boundaries of Cordillera Administrative Region (CAR) and participated in by representatives from different organizations within the region and sanctioned by the government through any recognized government agency;

Section 4. Provincial Competition: It is defined as any event/activity held within the boundaries of Benguet Province and participated in by the representative from the different organizations within the province and sanctioned by the government through any recognized government agency;

RULE III. COMPETITION OR CONTEST COVERED BY THIS ORDINANCE

Section 1. Persons covered: Those who will be given financial or monetary reward as per this ordinance are those winners with their respective coaches as official representatives of this municipality duly authorized by the Barangay and Municipal Sports Development Coordinator and who compete in any provincial, regional, national, or international sports, skills and academic contest, and who bring prestige to this locality by bringing home gold, silver or bronze medals or First Runner-Up, Second Runner-Up or championship trophy.

Section 2. Monetary Awards/Citations: The following monetary reward shall be given to the athletes and coaches, as follows:

RULE IV. MISCELLANEOUS PROVISION

Section 1. Additional Awards: Citations or other congratulatory gestures may be given through legislative acts of the Sangguniang Bayan.

Section 2: Certifying Agency/Entity: As basis of this LGU to award such monetary incentive to qualifying sports and skills competition participants, the Dep-Ed District Supervisor concerned shall issue a Certification, stating therein that the student was a participant in such sports or skills competition, further reflecting therein the award received in the event they participated. Additional documents, such as but not limited to certification from the governing agency or the sports coordinator of their district and/or any picture taken during the awarding ceremony may be presented to attest to the veracity of the claim.

Section 3: Procedures of Claim: The student/pupil awardee/claimant or his/her duly authorized representative as covered by an authorization letter from the awardee/claimant himself/herself shall submit duly signed Certification and other optional documents are set forth under Section 2, Rule IV of this IRR to the Secretariat of the Local School Board. The Secretariat shall then prepare the other needed documents and submit the same to the proper office for the processing and release of the claim.

RULE V. SOURCE OF FUND

Section 1. Funding: The amount of Two Hundred Fifty Thousand (Php 250,000.00) pesos shall be incorporated in the Annual Municipal Budget for this purpose.

RULE VI. FINAL PROVISIONS

Section 1. Amendment: This IRR may be amended to correspond with the amendment of Ordinance No.39,S. 2012, if there be any, and as often as the need arises. Any amendment hereto shall be applicable after the date of effectivity of the said amendment.

Section 2. Separability Clause: If any provision in this IRR or application of such provision to any circumstance is found or declared to be unconstitutional or invalid, the other provisions not affected thereby shall remain valid and subsisting.

Section 3. Repealing Clause: All Ordinances, Resolutions and Regulations or part thereof that are inconsistent with Municipal Ordinance No. 39, S. 2012 as amended are repealed or modified accordingly.

Section 4. Effectivity Clause: This IRR shall take effect immediately upon approval.
