AN EXECUTIVE ORDER CREATING THE ADOLESCENT AND YOUTH HEALTH DEVELOPMENT (AHYD) AND ITS TECHNICAL WORKING GROUP

WHEREAS, the Adolescent Health and Youth Development Program is POPCOM's response to the growing awareness worldwide on the reproductive health issues and concerns of the youth and their significant contribution to future population and health trends;

WHEREAS, projects being conducted under this program include media outreach, skills training and enhancement programs, peer counselling, and support to other youth programs and projects;

WHEREAS, as per report of the representatives who attended the Adolescent Health Development Program cum Planning Workshop, they were oriented with the increasing incidence of teenage pregnancy and other identified needs, issues, concerns and problems of our adolescents in the municipality, there is a need to create the Adolescent and Youth Health Development (AYHD) Council and its Technical Working Group;

NOW, THEREFORE, I, ATTY. VICTORIO T. PALANGDAN, by virtue of the powers vested in me by law as Mayor of the Municipality of Itogon, Benguet, do hereby create the Adolescent and Youth Health Development (AYHD) Council and its Technical Working Group with their functions to wit:



FUNCTIONS:

General:

The AYHP Council shall be the over-all coordinating and implementing body for the implementation of the AHYP Strategy and Plan in the municipality, with the emphasis on the reduction of unintended teen pregnancy and adolescent childbirth.

Specific Functions:

- Spearhead formulation of a comprehensive AHYP Framework and Operational Plan and oversee its implementation;
- Ensure provision of financial resources from the municipal government to support the implementation of AYHD program in the locality;
- Undertake program monitoring and evaluation and provide a program feedback mechanism;
- In close coordination with the barangay officials and other agencies concerned, continuously identify the needs, issues, concerns and problems experienced by adolescents such as those related to physical, social, psychological development, behavioral, unsafe behaviors such as bullying and conflict with the law, unintended teen pregnancy, and lead the various stakeholders in formulating appropriate responses;
- Provide support in strengthening the capacities for the various service providers involved in AYHD program through the conduct of training courses and other capacity-building activities;
- Establish and maintain linkages with local, national including international population serving organizations or institutions;

- Establish sustainable programs/projects/activities related to adolescent health and development focused on the following:
 - Healthy development
 - Healthy nutrition
 - Sexual and reproductive health
 - Reduction of substance use
 - Reduction of injuries and mortality, morbidity and psychological consequences of injuries
 - Mental health

- Prepare the agenda for AHYP quarterly meetings.
- Keep records of minutes, activities and programs of AHYP.
- Prepare budget proposals for the AHYP for inclusion in the appropriation ordinance.

This Executive Order shall take effect immediately upon approval.
