EXECUTIVE ORDER NO. 03-2017

CREATING THE MULTI-HAZARD CHILD VULNERABILITY ANALYSIS AND MAPPING SYSTEM (MHCVAMS) TECHNICAL WORKING GROUP OF THE MUNICIPALITY OF ITOGON

WHEREAS, the Philippines is situated within the “Pacific Ring of Fire” which makes it most vulnerable to natural hazards such as earthquakes, floods, tsunamis, landslides, volcanic eruptions and droughts, becoming more intense and unpredictable as these are further enhanced by the negative impacts of climate change;

WHEREAS, UNICEF is undertaking measures to address disaster risk by incorporating risk reduction in its programs which include the promotion of child-centered DRR in order to strengthen the resilience of children, their parents, the community and government thereby contributing to capacity development;

WHEREAS, the UNICEF, in collaboration with the Philippines Government through the Philippine Geographical Society, the Municipal Government of Itogon and the Cordillera Disaster Response and Development Services (CorDis RDS) will be conducting a Multi-Hazard Child Vulnerability Analysis and Mapping System in the locality it, being a part of the Child-Centered Participatory Approaches and GIS for Disaster Risk Reduction Phase 2 (CPAG-DRR 2) aimed at providing a definitive avenue for multi-sectoral dialogues on workflows regarding the production of critical geospatial information such as maps;

NOW THEREFORE, by virtue of the powers vested in me as Local Chief Executive, I, **ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby create the Multi-hazard Child Vulnerability Analysis and Mapping System Technical Working Group (MHCVAMS-TWG) in the Municipality of Itogon, to wit;

Section 1. Composition. The MHCVAMS-TWG IN THE Municipality of Itogon is hereby created and shall be composed of the following:

1. Representatives from the following offices:
 - a. Municipal Mayor’s Office;
 - b. Municipal Engineering Office;
 - c. Municipal Planning and Development Office;
 - d. Municipal Assessor’s Office;
 - e. Municipal Agriculturist’s Office;
 - f. Municipal Health Office; and
 - g. Municipal Social Welfare and Development Office

2. Representatives of the following national offices/agencies operating within the municipality:
 - a. DILG;

- b. Philippine National Police; and
 - c. Bureau of Fire Protection
3. DepED District Supervisors of Itogon Districts I and II;
 4. All Punong Barangays; and
 5. The Municipal Disaster Risk Reduction and Management Officer

Section 2. Duties and Functions. The Technical Working Group shall perform the following duties and functions, to wit;

1. To provide assistance to the participating agencies/offices in the formulation and establishment of a municipal data base through the following:
 - a. provision of related information such as geospatial data and household data;
 - b. provision of appropriate data for the preparation of overlay maps which could be utilized as tools for program planning and implementation and for advocacy on child-centered DRR and CCA;;
 - c. coordinate and organize community-based risk assessment activities in different barangays as may be needed;
2. Coordinate with other concerned offices/agencies for purposes of gathering pertinent records, data or information that are equally essential in the formulation of the municipal data base;
3. Attend all meetings, trainings and workshops to be conducted by UNICEF through the Philippine Geographical Society and CorDis RDS in relation with the setting up of a Multi-Hazard Child Vulnerability Assessment and Mapping System in the municipality; and
4. Perform such other functions as may be directed by the Local Chief Executive.

Section 3. Repealing Clause. All Executive Orders and Issuances inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

Section 4. Effectivity. This Order shall take effect immediately.
