CREATING THE MUNICIPAL PHYSICAL FITNESS AND SPORTS DEVELOPMENT COUNCIL

Whereas, the Sangguniang Bayan of this municipality enacted Ordinance No. 011, s2019, entitled "Ordinance Revising Ordinance No. 006, s2016 entitled: "An Ordinance Institutionalizing the Conduct of Palarong Bayan and All Sports Competition in the Municipality of Itogon, Benguet Province and Providing Funds Therefor", Providing for the Guidelines for its Thorough Implementation."

Whereas, Section 7 of the above-said ordinance provides for the composition of the Municipal Physical Fitness and Sports Development Council (MPFSDC);

Now therefore, by virtue of the powers vested in me by law and pursuant to Municipal Ordinance No. 011, s.2019, I, VICTORIO T. PALANGDAN, in my capacity as the Local Chief Executive of the Municipality of Itogon, do hereby issue this Executive Order as follows:

Section 2: POWER and FUNCTIONS. The Municipal Physical Fitness and Sports Development Council (MPFSDC) shall:

- a. Formulate annual Sports Development Plan and the budgetary requirements for each sport events. The same shall be submitted to the Municipal Planning and Development Office (MPDO) on or before 1<sup>st</sup> week of April of every year to be incorporated in the Annual Investment Plan of the municipality.

Furthermore, in the event that the MPFSDC decided to alter their Annual Municipal Sports Development Plan, which was already incorporated in the approved AIP of the Municipality, the Council shall request the Sangguniang Bayan for possible revision of both plans.

- b. Recommend to the Local Chief Executive rules and regulations to implement the provisions of Ordinance No. 11, s2019.
- c. Perform such other functions as may be duly authorized by law on Physical Fitness and Sports Development.

### Section 3. REGULAR and SPECIAL MEETING.

The MPFSDC shall set its internal Rules of procedure which shall include the schedule of its regular and special meeting.

Section 4. SEPARABILITY CLAUSE. Should any part of this Executive Order be declared inconsistent by any competent authority, the other provisions not declared otherwise shall be in effect and enforceable. .

Section 5. EFFECTIVITY. This Executive Order shall be effective immediately upon its release..
