## EXECUTIVE ORDER NO 10 Series of 2021

ORDERING THE IMPOSITION OF GRANULAR LOCKDOWN OVER SITIOS BUA EAST AND WEST OF BARANGAY TUDING EFFECTIVE 12:00 IN THE MORNING OF AUGUST 26, 2021 UNTIL 11:59 IN THE EVENING OF AUGUST 29, 2021.

WHEREAS, the increase in number of COVID-19 positive cases in Sitios Bua East and Bua West, both of barangay Tuding, this municipality requires the implementation of drastic measures to contain the spread of the virus in the vicinities of these areas and in order to prevent widespread of cases in the locality;

WHEREAS, the implementation of a granular lockdown in the aforementioned sitios shall enable our concerned personnel to efficiently conduct contact tracing, isolation and disinfection;

NOW THEREFORE, by virtue of the powers vested in me as the Local Chief Executive of the Municipality of Itogon, in accordance with law, rules and regulations, I, ATTY. VICTORIO T. PALANGDAN, do hereby ORDER as follows:

Section 1. Granular Lockdown is hereby imposed at Sitio Bua East and Sitio Bua West, both within Barangay Tuding effective 12:00 AM of August 26, 2021 until 11:59 PM of August 29, 2021.

Section 2. The Punong Barangay concerned shall strictly implement this order over the sitios aforementioned and shall coordinate with the Municipal Health Office for the conduct of contact tracing, isolation and disinfections; to the Municipal Social Welfare and Development Office for the provision of food and essential supplies to those affected; to the IMPS for the provision of personnel to secure the areas; and to all other concerned agencies/offices for the provision of other assistance to address immediate needs of residents:

Section 3. Authorized Persons Outside Residence (APOR) shall be allowed entry and exit at established quarantine checkpoints upon presentation of pertinent Identification Cards or any similar documents;

Section 4. At the duration of the granular lockdown, retail stores within the affected areas selling food, over-the-counter medicines and other basic household necessities may be allowed to operate subject to the strict observance of minimum health standards and to the limitation on the number of customers allowed within each premises as well as to the prohibition of by-standers thereat;

Section 5. This Order shall take effect immediately.
