CREATING THE MUNICIPAL DEVOLUTION TRANSITION COMMITTEE OF ITOGON

Whereas, the Local Government Code provides among others, for a more responsive and accountable located government structure through a system of decentralization giving more powers, authorities, responsibilities and resources;

Whereas, the Supreme Court ruled in the Mandanas- Garcia petitions that the basis for computation of local governments' share shall include all collections of national taxes;



Whereas, based on the Supreme Court Ruling in the Mandanas- Garcia petitions, the implementation of the clarified shares of local government units from the collection of taxes shall start in the year 2022;


Whereas, local government units are mandated to prepare their respective Devolution Transition Plans for the smooth implementation of the Mandanas- Garcia ruling.


