## CREATING THE PLANNING TEAM FOR THE PREPARATION OF THE 2023-2025 LOCAL INVESTMENT PLAN FOR HEALTH OF THE MUNICIPALITY OF ITOGON (LIPH)

WHEREAS, Section 15, Article II of the 1987 Constitution mandates the state to protect and promote the right and health of the people and instill consciousness among them;

**WHEREAS,** on February 20, 2019, President Rodrigo Duterte signed into law RA 11223, An Act Instituting the Universal Health Care for all Filipinos, Prescribing Reforms in the Health Care System and Appropriating Funds Therefor;

**WHEREAS**, Administrative Order 2020-0022 on Guidelines on the Development of Local Investment Plans for Health and AO 2020-0018 on Guidelines on Contracting Province-wide and City-wide health systems shall guide the LIPH and AOP processes.

**WHEREAS**, the Local Investment Plan for Health in a three-year strategic planning cycle that is applied at all levels in the locality and is guided by the National Objectives for Health.

**NOW THERFORE,** by virtue of the powers vested in me, I ATTY. VICTORIO T. **PALANGDAN,** Municipal Mayor of the Municipality of Itogon, Benguet Province hereby **ORDER** as follows, to wit:
