**REORGANIZING THE ITOGON MUNICIPAL ACTION TEAM ON DEMOLITION OF ILLEGAL STRUCTURES**

Whereas EO No. 16, Series 2020 established Itogon Municipal Action Team on Demolition of Illegal Structures pursuant to reports that there are structures being constructed and/or were constructed recently by unscrupulous persons without the requisite building permit and without any proof of ownership or claim of ownership over areas that are either public land, forest land, mineral land or owned by other individuals;

Whereas there are demolition orders that need to be implemented following the denial of the preliminary injunction cases filed against the Office of the undersigned, Office of the Building Official and even the Itogon Municipal Action Team on Demolition of Illegal Structures;

Whereas there is a need to reorganize the Municipal Action Team to add members in order to effectively carry out the functions of the Municipal Action Team;

Now therefore, by virtue of the powers vested in me as the Local Chief Executive of the Municipality of Itogon, I, **BERNARD S. WACLIN**, do hereby issue this Executive Order reorganizing the Itogon Municipal Action Team on Demolition of Illegal Structures as follows:

Section, MDRRMO, responders, and the members of the Barangay Peacekeeping Action Team (BPAT) of the concerned barangay

The Philippine National Police - Itogon shall provide security during the activity to ensure safety and to avoid any untoward incident.

**Section 2. Functions of the Action Team.** The Itogon Municipal Action Team on Demolition of Illegal Structures shall oversee and implement the summary eviction of squatters and demolition of illegal structures pursuant to the provisions of RA 7279 and its IRR and PD No. 1096 and its IRR.

**Section 3. Effectivity.** This Executive Order shall be effective immediately.
