REORGANIZING THE REGULATORY REFORM TEAM (RRT) OF APINICIPALITY OF ITOGON, DESIGNATING ITS MEMBERS, EXECUTIVE ORDER NO. 14, SERIES OF 2020 AND FOR OTHER PURPOSES.

WHEREAS, Section 5 of Republic Act No. 11032 or the Ease of Doing Business Efficient Government Service Delivery Act of 2018 mandates all government service viders to regularly undertake cost compliance analysis, time and motion studies, E Sufficiency and improvement of their transaction systems and procedures and in in in in its indicate the same if deemed necessary to reduce bureaucratic red tape and processing time;

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2018-214 enjoining all Local Government Units to initiate reengineering of its operations and processes in line with the Philippine Development Plan 2017-2022 which ensures people-centered, clean and efficient governance through seamless service delivery;

WHEREAS, the DILG and the Anti-Red Tape Authority issued Joint Memorandum Circular No. 01, series of 2019 prescribing guidelines for regulatory reforms in government units;

WHEREAS, local government units are enjoined under the Joint Memorandum Circular to review business and non-business related local ordinances, issuances or resolutions to effect regulatory reforms that will redound to the enhancement of performance, promote cost-effectiveness, and efficiency, and improve quality of regulations and related government formalities; and further, to improve economic performance; MAP 1 4
