REORGANIZING THE REGULATORY REFORM TEAM (RRT) OF THE MUNICIPALITY OF ITOGON, DESIGNATING ITS MEMBERS, AMENDING EXECUTIVE ORDER NO. 14, SERIES OF 2020 AND FOR OTHER PURPOSES.

WHEREAS, Section 5 of Republic Act No. 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 mandates all government service providers to regularly undertake cost compliance analysis, time and motion studies, undergo evaluation and improvement of their transaction systems and procedures and reengineer the same if deemed necessary to reduce bureaucratic red tape and processing time;

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2018-214 enjoining all Local Government Units to initiate reengineering of its operations and processes in line with the Philippine Development Plan 2017-2022 which ensures people-centered, clean and efficient governance through seamless service delivery;

WHEREAS, the DILG and the Anti-Red Tape Authority issued Joint Memorandum Circular No. 01, series of 2019 prescribing guidelines for regulatory reforms in local government units;

WHEREAS, local government units are enjoined under the Joint Memorandum Circular to review business and non-business related local ordinances, issuances or resolutions to effect regulatory reforms that will redound to the enhancement of performance, promote cost-effectiveness, and efficiency, and improve quality of regulations and related government formalities; and further, to improve economic performance;

WHEREAS, consistent with Republic Act 11032, DILG Memorandum Circular No. 2018-214, ARTA-DILG JMC No. 01-2019 and other related guidelines and issuances, the Regulatory Reform Team of the Local Government of Itogon was created by virtue of Executive Order No. 14, series of 2020;

NOW THEREFORE, by virtue of the powers vested in me by law, I, **HON. BERNARD S. WACLIN**, in my capacity as Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby **ORDER** the reorganization of the Regulatory Reform Team of the Municipality of Itogon and for other related purposes, to wit;
