REORGANIZING THE MUNICIPAL ADVISORY GROUP FOR POLICE TRANSFORMATION AND DEVELOPMEN (MAG-PTD) TO INCLUDE THE REPRESENTATION OF OTHER CONCERNED AGENCIES, OFFICES OR SECTORS IN THE COMPOSITION THEREOF, PROVIDING FOR THE DESIGNATION OF A SECRETARIAT, AND AMENDING PERTINENT PROVISIONS OF EXECUTIVE ORDER NO. 7, SERIES OF 2019 AND ADMINISTRATIVE ORDER NO. 40, SERIES OF 2022 RESPECTIVELY.

WHEREAS, the Peace and Order Agenda of Transformation and upholding of the Rule of Law Plan 20130 (otherwise known as P.A.T.R.O.L. Plan 2030) was developed as part of the national government's innovation to transform the image of the PNP and improve the quality of its services, making it a world-class organization with proficient and professional personnel;

WHEREAS, various units performing corresponding tasks were organized under the P.A.T.R.O.L. Plan 2030 among which is the Center for Police Strategy Management under which the Performance Governance System is attached;

WHEREAS, the Municipal Advisory Council for Police Transformation and Development and Performance Governance System was established in the municipality by virtue of Executive Order No. 07, series of 2019 and was subsequently reorganized by virtue of Administrative Order No. 40, series of 2022 along with the renaming thereof to Municipal Advisory Group for Police Transformation and Development (MAG-PTD) in accordance with NAGPTD Resolution No. 2021-002;

WHEREAS, during the MAG-PTD meeting held on June 15, 2023, the members of the body recommended for the inclusion of representatives from the BJMP, BFP, MHO, MSWDO and PTA Federation in the composition thereof considering the participation of these agencies/sectors in addressing peace and order issues in the municipality;

WHEREAS, there is also a need to designate a MAG-PTD secretariat to provide technical and administrative support to the body;

NOW THEREFORE, by virtue of the powers vested in me by law, I. **HON. BERNARD S. WACLIN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby ORDER as follows:

Section 1. Reorganization and Composition. The Municipal Advisory Group for Police Transformation and Development and Performance Governance System (MAG-PTD) is hereby reorganized to include representatives from the BJMP, BFP, MHO, MSWDO and PTA Federation in the membership thereof. As such, the MAG-PTD shall be composed of the following:



Section 3. Functions. Consistent with the P.A.T.R.O.L. Plan 2030, the MAG-PTD-PGS shall perform the following functions:

1. Advise and assist the Itogon Municipal Police Station in identifying key priorities and strategic issues in line with PNP PATROL Plan 2030, and provide insights in aligning the PNP's policies, plans and programs with the political, socioeconomic, cultural and moral development needs of the municipality;

- Assist the IMPS in resource generation and mobilization to enable members of the PNP to effectively perform their duties and functions of maintaining peace and order in the locality and in pursuance of their strategic priorities as laid out in the PATROL PLAN 2030;
- Initiate forums and similar activities for purposes of formulating a multi-sectoral coalition that would heighten linkages between the PNP, the community and all stakeholders;
- 4. Conduct periodic assessment on the performance and functionality of the IMPS and shall inform the latter on the result of such assessment for its analysis in order to enable our local police force to identify their strengths and weaknesses with the end view of bringing back the good image of the law enforcement agency;
- 5. Perform other related functions as may be directed by law or ordinance.

Section 4. Secretariat, designation. There is hereby created a MAG-PTD Secretariat to provide the body with technical and administrative support. For this purpose, PSSg ALMA JANE A. KILLASE is hereby designated as Head Secretariat. She may be assisted by personnel of the Municipal Government and/or from other memberagencies to be designated by the advisory group.

Section 5. Separability Clause. If for any reason, this Executive Order or parts hereof has been declared invalid or unconstitutional by competent authority, parts thereof not affected by such declaration shall remain to be in force and effect

Section 6. Repealing Clause. Section 1 of E.O. No. 7, series of 2019 and Section 2. Of A.O. No. 40, series of 2022, both providing for the composition of the MAG-PTD are hereby amended. Similarly, all Orders and/or Issuances inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

Section 7. Effectivity. This Executive Order shall take effect immediately.
