CREATING THE COMPOSITE VALIDATION AND ASSESSMENT TASK TEAM (CVATT)
OF THE MUNICIPALITY OF ITOGON, BENGUET PROVINCE.

WHEREAS, the Department of Interior and Local Government issues various policies on road clearing operations and one of which was Memorandum Circular No. 2023-017 dated January 25,2023 which directed LGUs to conduct road clearing operation and barangay road clearing operation (BaRCO) to reclaim public road;

WHEREAS, President Ferdinand R. Marcos Jr. On January 5,2024 called on Local Government Units to exert efforts towards cleanliness and orderliness and urged local officials to take the lead in clearing up roads, canals, markets and schools;

WHEREAS, Memorandum Circular No.2024-053 of DILG directed the National Implementation of the Barangay, Road Clearing Operations, Assessment, Validation and Recognition under the Bagong Pilipinas Program and that a composite Validation and Assessment Task Team (CVATT) be created at all levels;

NOW THEREFORE, I, BERNARD S. WACLIN, by virtue of the powers vested upon me as the Mayor of the Municipality of Itogon, Benguet, do hereby created the COMPOSITE VALIDATION AND ASSESSMENT TASK TEAM, (CVATT) of the municipality as follows:

Section 1. Composition. The Composition Validation and Assessment Task Team (CVATT) of the Municipality of Itogon shall be composed of the following:

Section 2. Functions. The CVATT shall perform the following functions:

- Coordinate with and inform the concerned MLGOO and the Municipal Mayor of the assigned LGU regarding the schedule of the BaRCO validation and assessment;
- Conduct on-the-ground validation and assessment in the assigned LGU;
- 3) Check the presence of road obstruction in alleys and streets;
- 4) List down types of road obstruction that were present/observed form the time of validation and assessment. Road obstruction may include, but not limited to the following:
 - Illegal parked vehicles, e-bike, e-trike;
 - Vehicular terminals except in areas designated by the concerned LGU;
 - Vending sites for any kind of item;
- House encroachments that obstruct the road-right-of-way, protruding gates, OFFICE OF THEONOLUGE household activities, and tents, except those being temporarily used for funerals and similar activities;

Store encroachments and indiscriminate signage and advertisement;

- Obstructing barangay outposts, halls, markers and directories;
- Conduct of sports, sports facilities and other related activities;
- Drying of rice and other crops;
- Construction materials including sand, gravel, cement, steels bars, log and the like:
- Debris waste materials and other junked items;
- Steel plates, makeshift shelters, barriers that obstruct the safe movement of vehicles and pedestrians; and
- Other structures, materials, or activities identified by the LGU as obstructions through their road inventory.
- 5) Accomplish and sign the corresponding BaRCO Validation and Assessment Form, and submit the same to the concerned Provincial Officer;

Section 3. Effectivity. This Executive Order shall take effect immediately and shall be valid until revoked or amended.
