RECONSTITUTING THE COMPOSITION OF THE SEAL OF GOOD LOCAL GOVERNANCE -LOCAL GOVERNANCE PERFORMANCE MANAGEMENT SYSTEM (SGLG-LGPMS) TEAM

WHEREAS, SGLG-LGPMS as an assessment tool to assess performance and state of development using performance measures to gather raw data from local governments;

WHEREAS, SGLG-LGPMS is a performance management tool that helps identify development gaps and further guides local government units to develop executive and legislative actions to address such gaps;

SECTION 4. FUNCTIONS OF THE SGLG-LGPMS FOCAL PERSONS

- 1. Responsible in the online encoding of the LGPMS data entry which includes the SGLG data collection and certification form (LGU Profile) in the system;
- 2. In-charge in the compilation of requirements (both hard copy and electronic copies) as required by DILG;
- 3. Prepare other MOVs/documents as required relative to the assessment; and
- 4. The team leader shall be the SGLG Focal Person who shall be responsible in facilitating the SGLG requirement of all concerned for submission to DILG, provide technical support, and such other assistance as maybe required in the discharge of its functions.

SECTION 5. SCHEDULE OF MEETING. The SGLG-LGPMS Team shall meet quarterly as often as necessary and when major issues and concerns need to be addressed immediately.
