**SUBJECT: CREATING AND INSTITUTIONALIZING THE LOCAL INVESTORS SOCIAL DEVELOPMENT MANAGEMENT AND CORPORATE SOCIAL RESPONSIBILITY PROGRAMS COORDINATING COMMITTEE (SDMP-CSR-CC) OF THE LOCAL GOVERNMENT UNIT OF ITOGON, BENGUET**

**WHEREAS**, in concrete response to the call of the Aquino administration for a Public-Private Sector Partnership in ushering holistic and sustainable development in the country, the current local administration endeavors to enter into joint undertakings with the private sector, more particularly the local investors, such as the mining and water-based industries to enshrine complimentary and participative strategic approach to ensure the mutual attainment of the social development priorities and agenda of the local government unit of Itogon and the local investors as well;

**WHEREAS**, as part of their commitment to work for the sustainable development of the host communities, and in response to their Corporate Social Responsibilities, the local investors allot under their respective annual appropriation funds to finance the implementation of their Corporate Social Responsibility and Social Development Management Programs which are usually identified and prioritize by the host communities themselves;

**WHEREAS**, it has been observed that almost all of the projects, programs and activities which are accommodated and funded by the local investors for implementation are the same social development priorities which the Local Government Unit of Itogon ardently seeks and desires to address;

**WHEREAS**, there is a need to foster collaborative and consultative undertakings by and among the Local Government Unit of Itogon and its local investors in the prioritization and consideration of social development programs towards the formulation and institutionalization of a comprehensive and complimentary social development plan ensure concerted efforts from among the parties and the maximization of their financial resources towards the successful realization of their common social development goals and objectives;

**WHEREAS**, there is then a need for the Local Government Unit of Itogon to create and institutionalize a Coordinating Committee to closely coordinate with its Local Investors towards the formulation, institutionalization, funding and implementation of a comprehensive and holistic social development program;

**NOW, WHEREFORE**, by virtue of the power and authority vested in me by law, I, OSCAR MAINGPES CAMANTILES, do hereby create and institutionalize the Local Investors Social Development Management and Corporate Social Responsibility Programs Coordinating Committee (SRDMP-CSR-CC) of the Local Government Unit of Itogon, Benguet, to wit:



Section 2: Functions and Duties: The duties and functions of the SDMP-CSR-CC shall be as follows:

- 2.1) To closely coordinate with the local investors during the formulation and institutionalization of the social development programs of the former to ensure that the same priority programs are incorporated in the Municipal Development Plan of the Local Government Unit of Itogon;
- 2.2) To advise the local sanggunian as may be called for on SDMP and CSR matters which will require legislative measures to ensure the successful implementation thereof;
- 2.3.) To assist the local investors in bringing to the attention of the Local Government Unit their SDMP-CSR concerns and issues which may be needing support and complimentary assistance.
- 2.4.) To perform other related functions which may be called for from time to time.

This Administrative Order takes effect immediately.
