**AMENDING ADMINISTRATIVE ORDER NO. 049 REORGANIZING THE MUNICIPAL ECOLOGICAL SOLID WASTE MANAGEMENT TECHNICAL WORKING GROUP IN COMPLIANCE WITH REPUBLIC ACT NO. 9003 AND IT'S IMPLEMENTING RULES AND REGULATIONS (IRR).**

There shall be a secretariat/recorder of the TWG to be composed of the following:


