**AMENDING THE COMPOSITION OF THE MUNICIPAL ECOLOGICAL SOLID WASTE MANAGEMENT BOARD IN COMPLIANCE WITH REPUBLIC ACT NO. 9003 AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR)**

**WHEREAS**, there is an existing Municipal Ecological Solid Waste Management Board of Itogon re-organized by virtue of Administrative Order No. 49-2010 dated September 14, 2010 ;

**WHEREAS**, the MESWM Technical Working Group (TWG) was amended by virtue of Administrative Order No.28-2011 to streamline the membership thereof;

**WHEREAS**, there was a change in the Chairmanship of the Liga ng mga Barangay due to the Liga Election conducted last December 2010. Thus, Hon. Eduardo B. Daniel shall become a member of the MESWM Board and Hon. Ramon L. Carino shall become a member of the MESWM Technical Working Group;

**WHEREAS**, with the above, there is a need to reorganize the membership of the Board to facilitate the implementation and monitoring of the Municipal Solid Waste Management Plan;

**NOW, THEREFORE I, OSCAR M. CAMANTILES**, Municipal Mayor of Itogon, by virtue of the powers vested in me by law, hereby reorganize the Ecological Solid Waste Management Board of Itogon;

HEAD - MS. MARLEEN M. GUERZON


