Subject: CREATING A SPECIAL TASKFORCE TO ASSESS THE SEVERAL PROPOSALS FOR ACCESS ROADS TO SITIO LUNETA AND DETERMINE THE ROUTE THAT WOULD MOST BENEFIT THE **STAKEHOLDERS**

WHEREAS, the Provincial Government of Benguet through the Office of Hon. Governor Nestor B. Fongwan, has allocated the amount of One Million Two Hundred Thousand Pesos (PhP 1,200,000.00) for the opening of the Luneta-Antamok Road;
