**ADMINISTRATIVE ORDER NO. 064**

**AMENDING A.O. NO. 54, SERIES OF 2010 RE: COMPOSITION OF THE MUNICIPAL CLEAN AND GREEN COMMITTEE OF THE MUNICIPALITY OF ITOGON**

**WHEREAS**, in view of the new set of local officials brought about by the last barangay election and the retirement of some members, there is a need to reorganize the composition of the Municipal Clean and Green Committee;

**WHEREAS**, there is an increasing global recognition of the need for concerted efforts towards a more effective management of the environment;

**WHEREAS**, the Philippine Government has officially recognized the need to maintain the integrity of the environment as manifested through Section 16, Article 11 of the constitution which provides that;

**“The State shall protect and advance the right of the people to a balanced and healthful ecology in accordance with the rhythm and harmony of nature”**

**WHEREAS**, this Constitutional objective is reinforced in the Local Government Code of 1991, Section 16 of the General Welfare Clause of the code which mandates local authorities to enhance the right of the people to a balanced ecology among others equally significant responsibilities;

**WHEREFORE**, by virtue of the powers vested in me, I hereby create the Municipal Clean and Green Committee to be composed of the following, to wit:
