ADMINISTRATIVE ORDER NO. 65 Series of 2011

CREATING THE EDITORIAL BOARD AND SUPPORT STAFF OF THE LOCAL NEWSPAPER NAMED AS "ITOGON TIMES"

WHEREAS, Ordinance No. 28, s. 20% provides the right of every constituent in the municipality to basic information on the various programs of the municipality through executive and legislative enactments that are undertaken by the Executive and Legislative branches of the Municipal Government;

WHEREAS, the Technical Working Group was constituted by virtue of Administrative Order 60, s. 2011 for the Establishment of a Local Newspaper;

WHEREAS, the Technical Working Group in their meeting last November 5 of last year had determined the feature, composition and name of the Local Newspaper paper dubbed as "Itogon Times"

That shall embody the ideals, vision, character and aspiration of the municipality and the constituency;

WHEREAS, the Technical Working Group had come up with a working draft that captures the various programs and activities of the municipality that focuses primarily on the previous 110th foundation day celebration;

WHEREAS, there is a need to formalize the composition of the Local Newspaper to cater to the establishment and needs of the paper as propose by the Technical Working Group and to see to fruition the objectives of this endeavor;

NOW THEREFORE, I, OSCAR MAINGPES CAMANTILES, duly elected mayor of the Municipality of Itogon, Benguet, by virtue of the powers and authority vested upon me by law, do hereby organize and create the Editorial Board and the Support Staff of the Local Newspaper;

Section I. COMPOSITION. The Editorial Board shall be composed of the following:

The Editorial Board shall be composed of the Editor-in-Chief, the Associate Editor, and the Advisers.

Contributors, if there be any, shall be from the different line agencies and departments, and other entities public or private, operating in the locality.

Section II. FUNCTIONS. The Board shall assume the following functions:

- 1. To create and establish the editorial policy of the Local Paper in line with the Municipal Ordinance as part of the Transparency and Good Governance Program of the Municipality
- 2. Coordinate with all the concerned private and government agency for the prompt submission of their contributory articles.
- 3. To come up with the first issue of the Local Paper this coming December, to be distributed during the 111th Foundation day celebration.
- 4. Perform other functions necessarily related to the publication of the newspaper.

This Administrative Order shall take effect immediately.
