CREATING THE HISTORIC SITES RESTORATION SPECIAL COMMITTEE

WHEREAS, one of the development thrusts of the Local Government Unit of Itogon is the development/enhancement and promotion its local eco-tourism industry;

WHEREAS, there are historical sites within the Municipality of Itogon which need restoration and be made parts of its eco-tourism industry, such as the historic Ave Maria shrine at Mount Bidawan, Barangay Poblacion, Itogon, Benguet;

WHEREAS, there a need to create a special committee which shall work out and spearhead the restoration of the Ave Maria Shrine, including all the other historical sites in the municipality of Itogon;

NOW THEREFORE, I, OSCAR M. CAMANTILES, by virtue of the powers vested in me by law as Municipal Mayor, do hereby create the Historic Sites Restoration Special Committee; to wit:

Section 2: Functions: of the Historic Sites restoration Special Committee:

1. To conceptualize and formulate designs and perspectives for the restoration/reconstruction of historic sites in the municipality of Itogon, such as the Ave Maria shrine and to come up with the necessary detailed estimates and program of works which shall be submitted to the Municipal Engineering Office for review and endorsement to the office of the Local Chief Executive for approval;
2. To plan out and coordinate fund raising activities in support to the historic sites restoration projects;
3. To assist in monitoring the progress of the implementation of the project;
4. To formulate and recommend policies and guidelines in managing the restored historic sites, such as the Ave Maria shrine to ensure sustainability and security;

Section 3. Effectivity: This Administrative Order shall take effect immediately and shall be valid until revoked or amended.
