## REORGANIZING THE MUNICIPAL SCHOLARSHIP BOARD

WHEREAS, the scholarship program had started in 1996 through Ordinance No. 4, S. 1996;

WHEREAS, said ordinance had been subsequently amended by virtue of Ordinance No. 8, S.1996 and Ordinance No. 45, s.2012;

WHEREAS, the spirit and intent of the Scholarship Program remains substantially the same except for the insertion of clearer provisions and the amount augmented from Four Hundred Thousand pesos (400,000.00) to One Million Pesos (1,000,000.00);

WHEREAS, in the deliberation of the 1996 version, there was a meeting of the minds of the Local Legislators that the number of scholars be equitably distributed among the nine (9) barangays of Itogon;

WHEREAS, there is a need to reorganize the Municipal Scholarship Board to be the policy making body of this program;
